

# TSA GRIEVANCE FORM

**To The Person Reading This Form:**

There is One Person, and One Person Only, who is responsible for your current inconvenience: **Barack H. Obama**. This is not a political viewpoint. It is a procedural fact.

The TSA is part of the Department of Homeland Security, a Cabinet Office of The President of The United States of America. Janet Napolitano is the secretary of this department, and is directly responsible for implementing TSA policy, but she is doing it under orders, or leave from **Barack H. Obama**. Period.

It does not matter whether you voted for him or not, whether you like him, or not, whether you are white, black, or any other color, or whether or not you like or dislike persons of any particular color or other.
